What is CYBERUK?

Strategy & Leadership

There is a formal networking dinner for the leadership community, bringing together individuals responsible for setting the cyber security strategy across government and industry.

Relaxed networking is a trademark of CYBERUK events and the informal networking evening kick starts this. This will feature thought-provoking talks, live music and refreshments.
